GMPs Part 111 Online Course

COURSE DESCRIPTION

This self-paced, online course covers the requirements of 21 CFR Part 111–Current Good Manufacturing Practice in Manufacturing, Packaging, Labeling, or Holding Operations for Dietary Supplements. It also addresses selected requirements in 21 CFR Part 117, Subpart B–Current Good Manufacturing Practice, Hazard Analysis, and Risk-Based Preventive Controls for Human Food that are relevant to the manufacture of dietary supplements.

CURRICULUM OVERVIEW

The course consists of 16 different modules. Participants who enroll in the course have 16 weeks to review each module at their own pace and complete quizzes within each module. Students will earn a Certificate of Completion issued by the Institute for Food Safety at Cornell University (IFS@CU) after passing each quiz with a score of 100%.

- Module 6:** Plant Design & Construction
- Module 7:** Equipment & Utensils
- Module 8:** Sanitary Operations: Cleaning & Sanitizing
- Module 9:** Establishing a Production and Process Control System & Quality Control Operations
- Module 10:** Laboratory Operations, Meeting Specifications, Material Reviews & Disposition Decisions
- Module 11:** Receiving
- Module 12:** Manufacturing Operations - Part 1
- Module 13:** Manufacturing Operations - Part 2
- Module 14:** Packaging, Labeling, Holding & Distributing
- Module 15:** Returned Dietary Supplements, Product Complaints, Records & Recordkeeping
- Module 16:** Building Written Procedures

WHO SHOULD TAKE THIS COURSE?

This course is intended for supervisors, middle-level managers, quality control personnel, and those responsible for ensuring that manufacturing, packaging, labeling, or holding dietary supplements meet current GMP requirements.

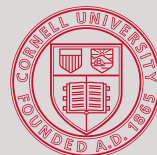
